### Hinckley Town Code, Chapter 20, Recreational Vehicles/Trailers

- 10-20-1 DEFINITIONS**  
 Recreational vehicle: A vehicle such as a recreational trailer, tent camper trailer, truck camper, travel trailer, motor home, boat or other such vehicles constructed to travel on public thoroughfares licensed or unlicensed.
- 10-20-2 PURPOSE**  
 To provide orderly and safe regulations for the usage and storage.
- 10-20-3 PERMITTED USES**  
 May not be used as a permanent residence. May be used as a temporary residence up to forty-five (45) days per year. Under special circumstances the Town Council may grant an extension of up to six (6) months that can be renewed up to two (2) times or more at the Council's digression.
- 10-20-4 STORAGE**  
 May not be stored for more than seventy-two (72) hours on public right of ways, any street, road or thoroughfare. May be stored on private property as long as it does not obstruct view for ingress or egress of driveways, sidewalks, or public roads as defined in Section 10-11-17.
